What can a care coordinator do for you?

A care coordinator can work with you to create a personalized care plan. They can act as a resource guide by referring you and your family to community resources. They can also provide emotional support and help with coping skills.

Care coordinators and other team members can assist with:

- Accompanying you to community activities for the first time
- Advocating for you –
 "We have your back"
- Applying for FoodShare/ finding food pantries
- Assisting with Division of Vocational Rehabilitation (DVR) services
- Helping with your personal budget
- Connecting you with parenting education
- Filling out Supplemental Security Income (SSI) applications

- Finding a counselor
- Finding a job
- Finding transportation resources
- Getting clothes
- Getting your General Education Diploma (GED)/ High School Equivalency Diploma (HSED) and/or attending college
- Referring to domestic violence support
- Advocating with legal services
- Assisting with scheduling primary care and other medical appointments

Do I qualify?

Those served include male and female clients
18 years of age or older with an opioid and/or
methamphetamine use disorder diagnosis living in
Forest, Vilas, Oneida, Iron, or Price County or Forest
County Potawatomi, Lac du Flambeau Chippewa, and
Sokaogon Chippewa Tribal Nations.
