Services include support and education in building independent living, budgeting, and tenancy skills; assistance with integration into community; and connections to community-based health care and treatment, employment services, social security benefits, and other community resources. Once a family has the skills and resources to live independently, they will be assisted in finding permanent, safe, affordable housing and may continue case management.</p>

They also offer a 9-month healing program for women (and their children) who are caught in the cycle of domestic abuse or alcohol/drug-related addiction.</i></p>	<p>Capacity: 7 beds (9-month program); 6 rooms/suites in Recovery Center for those who have completed the 9-month program; separate designated area for crisis stays</p> <p>Length of Stay: 2 weeks for emergency shelter; 9-month program; 1-2 years in the Recovery Center</p> <p>Persons Eligible: Women and children (males must be under 12 years old)</p> <p>Admission: Individuals must remain sober and follow general guidelines, including not stealing or being violent</p> <p>If Admitted: Emergency Shelter provides a safe environment, bed, shower, meal, clothing, and connection to resources. The shelter is a home-like environment in a secure building, providing a safe environment and assistance with basic needs (e.g., food, transportation, clothing). Advocates work closely with clients and their families to provide emotional support, legal advocacy, and children's support services and to determine longer term housing options.</p>

(715) 387-0528 <i>The Community Development Authority operates affordable housing for individuals and couples of all ages and abilities.</i></p>	<p>Persons Eligible: Anyone can apply for tenancy in public housing apartments. Low-income families may apply for Section 8 Housing vouchers through Allegiant Property Management, LLC, and must be within certain income limits to qualify based off their family size.</p> <p>Conditions/Assistance:</p> <ul style="list-style-type: none"> - Rent is calculated based off 30% of adjusted income and rent is set within the market limits. - For Section 8/Housing Voucher Program, there is no emergency funding. Eligible households will be placed on a waitlist after filling out the application. Applications are available through Community Development Authority, but must be returned to Allegiant Property Management, LLC.

For example, if an individual is behind 3 months' rent, FSET can only fund one of those months' rent. If a person is homeless or must move, FSET can fund both the security deposit and first month's rent.

Additional resources are offered to assist with housing difficulties to prevent homelessness or address current homelessness.

Individuals must have some type of income to support rent, copy of lease, and a letter from employer indicating wage, hours, and length of employment. - If receiving services: Individual meets with outreach director to review monthly budget; often includes vouchers for household items and/or clothing from thrift store and monthly food pantry visit.

W-2 is designed to ensure that everyone in Wisconsin shares our economic opportunities.</i></p>	<p>Persons Eligible:</p> <ul style="list-style-type: none"> - Custodial parent of minor(s) - At least 18 years of age - Single Refugee who arrived in the US within the last 8 months - US citizens or qualified aliens - Difficulty obtaining or maintaining employment - Have not quit or refused employment within previous 180 days without good cause - Meet specific financial and non-financial eligibility requirements - Not receiving SSI/SSDI <p>Conditions/Assistance:</p> <ul style="list-style-type: none"> - W-2 provides a cash payment of up to \$673 per month depending on placement. W-2 is a time limited program. No one may be on any placement for more than 24 months or W-2 for more than 60 months. This would include the receipt of TANF (Temporary Assistance for Needy Families) in other states. - If placed on W-2, expected to participate in up to 40 hours of activity per week. Activities could include a work site, job search, workshops, or classes. Single parents of a newborn infant can be exempted from activities until the child reaches the age of 8 weeks.
